- a. **Immediate Family** – includes grandparents, parents, children, grandchildren, siblings, (and the spouses of these listed groups) of the unit owner or unit owner’s spouse.
- b. **Family** – Persons related to the owner(s) or owner’s spouse by blood, marriage or adoption or a person not related but resides with the owner(s) as a single housekeeping unit or tenants not related but reside as a single housekeeping unit. **Non-immediate family members are treated as guests.**
- c. **Guest** – Any person physically present in or occupies a unit on a temporary basis without payment or other consideration.
- d. **Renter** – Any person who is physically present in or occupies a unit on a temporary basis at the agreement of the unit owner in exchange for valuable consideration. A renter can be referred to as a lessee.
- e. Owners “grandfathered” with a purchase date prior to June 2006 may rent their units for more than six days but not less than 30 days or one month, whichever is the lesser, only three times per year.
