**IMMEDIATE FAMILY – FAMILY – GUEST – RENTER REGISTRATION**  
– *When owner is not present* –

1. **Registration Type:** Immediate Family \_\_\_ Family \_\_\_ Guest \_\_\_ Renter \_\_\_
  - a. **Immediate family** includes grandparents, parents, children, grandchildren, siblings, (and the spouses of these listed groups) of the unit owner or unit owner’s spouse.
  - b. **Family** – Persons who are related to the owner(s) or owner’s spouse by blood, marriage or adoption or a person who is not so related but resides with the owner(s) as a single housekeeping unit or two tenants who are not related but reside as a single housekeeping unit. Non-immediate family members are treated as guests.
  - c. **Guest** – Any person who is physically present in or occupies a unit on a temporary basis at the invitation of the unit owner without payment or other consideration.
  - d. **Renter** – Any person who is physically present in or occupies a unit on a temporary basis at the agreement of the unit owner in exchange for valuable consideration. A renter can also be referred to as a lessee.
